The **USDA Animal Care** <u>Public Search Tool</u> may be used by the public to query information pertaining to facilities, inspections, and annual reports. The refined <u>Public Search Tool</u> provides access to Animal Welfare Act (AWA) compliance records, allowing APHIS to make animal welfare information publicly available and ensure compliance with all applicable laws.^{**}

APHIS' <u>Animal Care program</u> is responsible for the day-to-day administration of the AWA, including establishing acceptable standards of humane care and treatment for regulated animals and monitoring and achieving compliance through inspections, enforcement, education, and cooperative efforts. The AWA and its associated regulations seek to ensure the humane handling, care, treatment, and transportation of certain warm-blooded animals used or intended for use in research, exhibition, or as pets. Animal dealers and exhibitors must obtain a license, and research facilities, carriers, and intermediate handlers must obtain a registration. Animal Care inspectors conduct inspections of licensee and registrant animals, records, and facilities to assess compliance with the AWA and its regulations and document their observations and professional assessments in inspection reports. Licensees and registrants must notify Animal Care of changes in their operations and file periodic updates with Animal Care, including annual reports of animal use by research facilities.

This <u>Public Search Tool</u> lists persons licensed and registered under the AWA, inspection reports, and annual research facility animal use reports. Individuals or businesses seeking information or records that are not available through this Public

Search Tool may be able to find what they are looking for elsewhere at <u>Animal Care</u> or by submitting a request under the <u>Freedom of Information Act (FOIA)</u>.
