## **Phased Reopening of Southern Border Ports**

As of June 30, 2025, APHIS will implement a phased reopening of the southern border ports for the import of live cattle from certain Mexican States. Port-specific information and import eligibility can be found under "Ports of Entry" below. For more information about the phased reopening, see the USDA press release.



APHIS regulates the importation of all ruminants and their germplasm (embryos/oocytes, semen, cloning tissue) to prevent the spread of animal diseases. **Ruminants** include all animals that chew the cud, such as cattle, buffaloes, sheep, goats, deer, antelopes, camels, llamas, and giraffes.

# Southern Border Ports With Facilities Currently Approved by APHIS To Export Bovines to the United States:\*

- Douglas, AZ/Agua Prieta, Sonora—phased reopening to begin July 7, 2025.
- Columbus, NM/Palomas, Chihuahua—phased reopening to begin July 14, 2025.
- Santa Teresa, NM/San Jeronimo, Chihuahua—phased reopening to begin July 21, 2025.

At the above listed ports, cattle eligible for export include:

- Cattle born and raised in the Mexican States of Sonora or Chihuahua; or
- Cattle that are treated according to the <u>New World screwworm (NWS) protocol</u> when entering these states, prior to implementation of pre-export activities for subsequent export to the United States.

# Additional ports included in the phased reopening, pending facility approval and/or implementation of specific eligibility requirements:

- Del Rio, TX/Acuña, Coahuila—phased reopening to begin August 18, 2025.
- Laredo, TX/Colombia Bridge, Nuevo Leon—phased reopening to begin September 15, 2025.

### **Bovine Embryos**

Bovine embryos are **not** permitted to be imported from Mexico at this time.

## **Bovine Semen**

Bovine semen is **not** permitted to be imported from Mexico at this time.

### What You Need To Know

- U.S. transits are classified as shipments presented to a U.S. port of entry for conveyance purposes to then be transported to a destination country shortly after.
  - Notice Regarding APHIS Live Animal Import and Third-Country Import Transit Permits (272.29 KB)

- Please note that any animals and their germplasm transiting the United States must not transit countries with questionable disease statuses prior to reaching a U.S. port of entry.
- All transits require a contingency plan. Submit your contingency plan with your permit application (<u>VS 17-129</u> (211.74 KB)) to <u>laipermits@usda.gov</u>. To submit an import permit electronically, visit <u>APHIS eFile</u>.
- If you are applying to import live animals, semen, and embryos, you may submit applications by email to laipermits@usda.gov.
