

## CHILD CARE TUITION ASSISTANCE PROGRAM

### 1. PURPOSE

This Directive establishes the Child Care Tuition Assistance Program (CCTAP) for Animal and Plant Health Inspection Service (APHIS) employees.

### 3. POLICY

- a. It is APHIS policy to implement programs that provide child care tuition assistance to lower income employees to support their ability to receive quality child care services.
- b. APHIS is authorized to provide child care tuition assistance, and may use appropriated funds, including revolving funds, that are otherwise available for salaries and expenses, to assist lower income Federal employees with the cost of child care in child care centers and licensed family child care homes.
- c. Before this policy can be implemented for employees in recognized bargaining units, the Agency must discharge its bargaining obligations.
