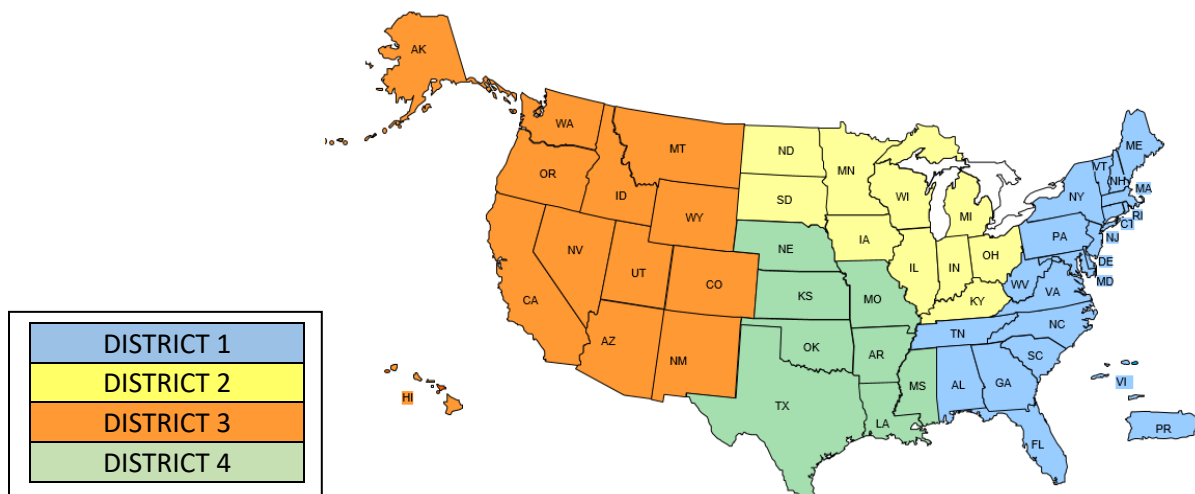


## Need Assistance with the Emergency Management Response System (EMRS)?
